

## **Before the Oregon Water Resources Commission**

In the Matter of the Withdrawal of Aquifers  
Within the Designated Woodland, Edison,  
Victor Point Area.

Final Order of Withdrawal

To: *Residents and Landowners Within the  
Designated Area*

*This is a final order in other than contested case subject to judicial review under ORS 536.075 and 183.484. Any petition for judicial review of this order must be filed within the time specified by ORS 183.484(2).*

The Oregon Water Resources Commission (Commission) issues this order pursuant to ORS 536.410, which authorizes the Commission to withdraw a source of water from appropriation for all or any uses including exempt uses under ORS 537.545.

### **Background**

The Water Resources Department (Department) has been investigating a question of water shortage in the Woodland, Edison, Victor Point area for several years. The Department initiated its investigation in response to a request from the Woodland, Edison, Victor Point Homeowners Association (Association) for technical assistance and information. Detailed ground water level data collection began in 1998 by the Department and the Association, working in cooperation with the Department. The data from the monitoring wells shows that most of the wells within the area have or nearly have fully penetrated the aquifer.

Based on the continued decline of their wells, and in reliance on the data from the monitoring wells, the Association submitted a petition for emergency rule making and to declare a critical ground water area to the Commission on July 5, 2001. The Department did not recommend the requested action to the Commission because 1) emergency rule making only allows a six month window of protection and development of administrative rules on critical ground water designation would take up to several years, 2) most of the water supply likely will be used before the designation would be helpful, and 3) sustainable, long term water supply will have to come from an outside source. In consideration of the Department's recommendation, the Commission denied the petition for emergency rulemaking and critical ground water area designation at its July 26, 2001, meeting. In lieu of the requested rulemaking, the Commission approved the Department's recommendation to begin the process to withdraw the aquifer from further development.

On August 23, 2001, the Department held a hearing to accept comments regarding the proposed withdrawal of the aquifers underlying the Woodland, Edison, Victor Point area. The

Department noticed the hearing for two consecutive weeks in a local newspaper, the *Silverton Appeal*. In addition, the Department noticed the hearing once in the Salem *Statesman Journal*, posted the notice on the Department's web site, and mailed notice of the hearing to all of the landowners in the affected area. The Department also allowed for submission of written comments on the proposed withdrawal.

### **Findings of Fact**

The subject withdrawal area, delineated in Attachment A, is approximately one square mile in size, and is adjacent to the City of Silverton and the Oregon Garden. The area is exclusively rural residential. The tax lots affected by the withdrawal are listed in Attachment B.

Aquifers underlie the designated geographic area. At issue here are aquifers that are within the Columbia River Basalt Group. A shallow aquifer exists in the shallow basalt and overlying sediments in some locations of the designated area. Wells in this aquifer generally, though not exclusively, are less than 100 feet deep. If the shallow aquifer is not encountered when drilling, wells are completed into a deeper aquifer or aquifers within the basalt. The deeper wells generally are between 400 and 550 feet deep.

The Department has detailed well monitoring data dating to 1998, as well as static water level measurements from each well dating to the date the well was drilled. These data show a continuous, precipitous rate of decline, particularly in the deeper wells. Based on data presented and explained to the Commission at its September 24, 2001 meeting, the decline appears to be independent of climate conditions. The rate of decline does not correlate to drought conditions or other significant climatic events. In fact, the rate of decline remained steady through years of above average annual precipitation. The data also support the conclusion that the deep wells are hydraulically connected. Based on the data, the Department projects that the water level of the deep wells will continue to decline until the resource is exhausted. The current rate of decline suggests that the deep wells may begin to fail within the next five years.

The shallow aquifer, while apparently stable under current demand, supplies some recharge to the deep aquifer(s). Indications of recharge from the shallow to the deep aquifer include the fact that the shallow aquifer levels respond consistently with precipitation and the absence of any known surface expression (such as springs) of discharge from the shallow aquifer that would account for all of the precipitation that had seeped into the groundwater. This information suggests that continued development of the shallow aquifer will deprive the deep aquifer(s) of some recharge, hastening the projected failure of the deep wells.

Testimony from the public hearing illustrates the concerns of the area water users and the condition of the water supply. Terry Cawlfeld, a homeowner and member of the Association, stated that eight wells had dried up just during this summer. Furthermore, Ms. Cawlfeld's well, which she stated to be the deepest well, is drawing salt water. Saline or brackish water is

produced by the geologic unit (Scotts Mills Formation) that is underneath the Columbia River Basalt Group.

### **Conclusions of Law**

ORS 536.410 authorizes withdrawal of unappropriated waters from any and all uses when the Commission determines (1) that it is necessary to insure compliance with the state water resources policy, or (2) that it is otherwise necessary in the public interest to conserve the water resources of this state for the maximum beneficial use. Both of these criteria are satisfied here.

The state water resources policy is expressed in statute. The explicit expressions of water resources policy allow for and contemplate withdrawal of a ground water supply where that supply is declining and the users are experiencing water shortages. ORS 536.220 expresses a policy interest in maintaining existing levels of general welfare and controlling the water resource in order to secure beneficial use of the state's water resources. Water supply policy declares that it is the policy of the state "to ensure a water supply sufficient to meet the needs of existing" uses. ORS 536.241(2). In regards to ground water, it is the state's policy to assure adequate supplies for human consumption, to determine and maintain reasonably stable ground water levels, and to control the use of ground water whenever declining ground water levels exist or when ground water supplies are being overdrawn. ORS 537.525(5), (7), (9). Here, the Commission is faced with a declining ground water supply that is projected to fail. Taking action to prohibit further appropriations of this ground water supply is consistent with the above expressed policy directives, particularly the directives to ensure adequate water supply for existing needs and to maintain reasonably stable ground water levels.

Moreover, as a more general matter, it is in the interest of public health and safety to take actions to prevent the accelerated decline of an existing ground water supply. The evidence in the record demonstrates that the continued development of the shallow and deep aquifers will hasten the decline of the deep aquifer and ultimately result in the failure of the existing wells that draw from the deep aquifer. The failure of a water supply presents a threat to public health and safety.

Under ORS 536.410, the Commission determines that it is necessary to insure compliance with state water resources policy and it is necessary in the public interest to withdraw from appropriation for all or any uses, including exempt uses under ORS 537.545, the shallow and deep aquifers in the Columbia River Basalt Group in the area delineated in Attachment A, affecting the tax lots listed in Attachment B.

**Order**


As determined by the Commission at its September 24, 2001, meeting:

1. The aquifers in the Columbia River Basalt Group in the area delineated in Attachment A are withdrawn from appropriation as follows:


- (a) All new uses requiring a water right permit.
- (b) All exempt uses from new wells with a priority date after September 24, 2001.
- (c) All new appropriation, initiated after September 24, 2001, from replacement wells or deepened wells that change from one aquifer to another.

2. This withdrawal order shall remain in effect until rescinded or modified by the Commission. The Commission may revoke or modify this order at any time on its own motion. At any time after September 24, 2003, a landowner or resident within the designated area may request the Commission to review the order for modification or revocation. All requests for modification or revocation submitted by a landowner or resident shall include supporting information and data.
