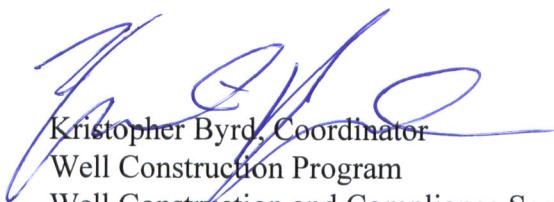
Dear Floyd:

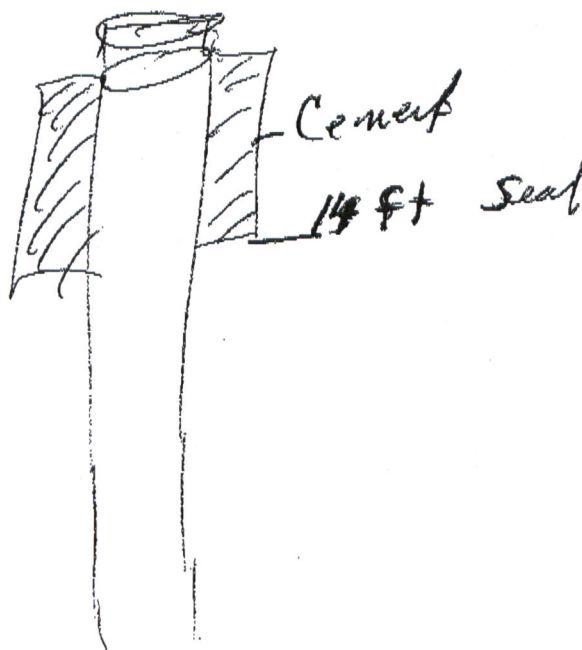
