The Special Standards Request Form you submitted for owner: Bill Stahl, Start Card number: 1077191, is hereby approved for the following: You may decommission this water supply well as described on your Special Standards Request Form dated April 16, 2025. All other well abandonment standards apply as required under Oregon Administrative Rules 690-220. A copy of your Special Standards Request Form is enclosed.

Approval of this Special Standards Request was granted on April 16, 2025, due to the photos you provided showing the lack of access for a drilling machine to the well location and the bent well casing.

(2) If it should be determined at some future date that the well, due to its construction, is allowing groundwater contamination, waste or loss of artesian pressure, the undersigned shall return to the site and rectify the problem.

(3) If oral approval was granted, a written request must be submitted to the Department either within three (3) working days of the date of oral approval or prior to completion of the associated well work. Failure to submit a written request as described above may void prior oral approval.
