CERTIFICATE OF WATER RIGHT

This is to Certify, That WALTER A. COVER

of Halfway, State of Oregon, has a right to the use of the waters of Clear Creek, tributary of Pine Creek, for Tracts Nos. 1, 2 and 5; Pine Creek for Tracts Nos. 4 and 5, and Dry Creek, tributary of East Pine Creek for Tract No. 6. for the purpose of Irrigation of 238.0 acres, and domestic and stock use for Tracts Nos. 1, 2, 3 and 6; Irrigation of 150.3 acres in Tracts Nos. 4 and 5, and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 11, at page 253; that the priority of the right thereby confirmed dates from 1874 for Tracts Nos. 1 and 4; 1886 for Tract No. 2, 1910 for Tract No. 3, 1881 for Tract No. 5, and 1883 for Tract No. 6.

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-fortieth of a cubic foot per second per acre, measured at the point of diversion, and a total limitation of one acre-foot per acre during July, one acre-foot per acre during August, and one-half acre-foot per acre during September, of each year.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:
