CERTIFICATE OF WATER RIGHT

This is to Certify, That JOHN IRWIN

of Halfway, State of Oregon, has a right to the use of the waters of Pine Creek for Tract No. 1, and Carson Creek for Tract No. 2,

for the purpose of Irrigation of 75.0 acres, domestic and stock use for Tract No. 1, and irrigation of 59.0 acres, domestic and stock use for Tract No. 2; and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 11, at page 235; that the priority of the right thereby confirmed dates from 1889 for Tract No. 1, and 1890 for Tract No. 2;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.5 cubic feet per second for Tract No. 1; and one-fortieth of a cubic foot per second per acre, measured at the point of diversion, and a total limitation of one acre-foot per acre during July, one acre-foot per acre during August, and one-half acre-foot per acre during September of each year, for Tract No. 2.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

 17.0 acres in NW<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub>  
 34.0 acres in SW<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub>  
 24.0 acres in SE<sup>1</sup>/<sub>4</sub>NW<sup>1</sup>/<sub>4</sub>  
 Section 55,  
 Township 7 south, Range 45 East, W. M.

TRACT No. 2  
 9.0 acres in NW<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub>  
 10.0 acres in SW<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub>  
 19.0 acres in NE<sup>1</sup>/<sub>4</sub>NW<sup>1</sup>/<sub>4</sub>  
 21.0 acres in SE<sup>1</sup>/<sub>4</sub>NW<sup>1</sup>/<sub>4</sub>  
 Section 26,  
 Township 7 South, Range 45 East, W.M.

(NOTE: The lands described under Tract No. 2 above have a supplemental supply through the Posey Valley ditch from Pine Creek with priority of 1890.)

AND said right shall be subject to all other conditions and limitations contained in said Decree.)

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
