## CERTIFICATE OF WATER RIGHT

This is to Certify, That R. S. DIXON,

of Fort Klamath

, State of

Oregon,

has a right to the use of

the waters of Sun Creek, tributary of Wood River,

for the purpose of Irrigation of 554.3 acres, domestic and stock use,

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Klemath County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 12, at page 269; that the priority of the right thereby confirmed lates from 1895:

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/50th of one cubic foot per second per acre irrigated prior to July 20th and 1/80th of one cubic foot per second per acre irrigated thereafter, and shall not exceed 5 acre feet per acre curing irrigation season from April 1st to October 1st of each year.
