## CERTIFICATE OF WATER RIGHT.

THIS IS TO CLATIFY that the OREGON-WASHINGTON RAILROAD & NAVIGATION COMPANY.

of Pittock Block, Portland, State of Oregon, has a right to the use of the waters of Tie Creek, Beaver Creek, and Meacham Creek, tributaries of the Umatilla River, and the Umatilla River, a tributary of the Columbia River, for railroad purposes, and that said right has been confirmed by Decree of the Circuit Court of the State of Oregon for Umatilla County, and the said Decree entered of record at Salem, in the Order Record of the State Water Board of Oregon, in Volume 3 at page 127; that the priority of the right hereby confirmed dates from 1888 for Tract No.1 from Tie Creek; 1888 for Tract No.2 from Beaver Creek; 1888 for Tract No. 5 from Meacham Creek; 1888 for Tract No. 4 from Meacham Creek, 1893 for Tract No. 5 from Umatilla River, and 1897 for Tract No. 6 from Meacham Creek; that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes.

A description of the lands irrigated under such rights, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the lace where such water is put to beneficial use, is as follows:

<u>Tract No. 1</u>, Duncan Station. Diversion in the Southwest quarter of Northwest quarter of Section Sixteen, Township One North, Range Thirty-six, East of Willamette Meridian, in Umatilla County, Oregon.

Tract No. 2, Meacham Station. Diversion in the Southwest quarter of Northonst quarter of Section Nine, Township One South, Range Thirty-five, East of Willamette Meridian, in Umatilla County, Oregon.

Tract No. 3, Huron Station. Diversion in the Northwest quarter of Northwest quarter of Section Eight, Township One South, Renge Thirty-six, East of Willamette Meridian, in Umatilla County, Oregon.

Tract No. 4, Gibbon Station. Diversion in the Southeast quarter of Northwest quarter of Section 6, Township Two North, Range Thirty-six, East of Willamette Meridian, in Umatilla County, Oregon.

Tract No. 5, Cayuse Station. Diversion in the Southwest quarter of Southwest quarter of Section Three, Township Two North, Range Thirty-four, East of Willamette Meridian, in Umatilla County, Oregon.

<u>Tract No. 6</u>, Camp Station. Diversion in the Northeast quarter of Southwest quarter of Section Fifteen, Township One South, Range Thirty-six, East of Willamette Meridian, in Umatilla County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

NOTE: This Certificate supersedes that certain water right certificate issued to the Oregon-Washington Railroad & Navigation Company, November 23, 1935, and recorded in State Record of Water Right Certificates, Vol. 10, Page 10,628, to confirm changes in points of diversion from Meacham Creek approved by Order of the State Engineer dated January 24, 1935, pursuant to Section 47-712 Oregon Code 1930.
