CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That BIG FLAT CATTLE COMPANY,

of Heppmer, State of Oregon, has a right to the use of the waters of WILLOW CREEK, tributary to the Columbia River, in Morrow County, Oregon,

for the purposes of irrigation and domestic use, (irrigation from January 1st to September 15th of each year)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Lorrow County, and the said decree entered of record at Salem, in the Order Record of the Board of Control of the State of Oregon, in Volume 1, at page 73; that the priority of the right hereby confirmed dates from 1894:

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.94 cubic feet per second.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

One and ninety-four hundredths (1.94) acres in NV of SV 1; five and forty-eight hundredths (5.48) acres in SV of SV; all in S2 16; thirty nine and eighty-four hundredths (39.94) acres in NE 2 of SE 2; twenty-four and four-tenths (24.4) acres in NV of SE 2; eighteen and twenty-six hundredths (18.26) acres in SV 2 of SE 2; thirty-nine and sixty-two hundredths (39.62) acres in SE 3 of SE 2; all in Sec. 17; thirty-nine and fifty-six hundredths (39.56) acres in NE 3 of NE 3; all in Sec. 20; eleven and sixty-six hundredths (11.66) acres in NV 3 of NE 3; all in Sec. 20; five and fifty-three hundredths (5.53) acres in NV 4 of NV 3; four and seventenths (4.7) acres in SV 5 of NV 2; twenty-one and forty-one hundredths (21.41) acres in NV 5 of SV 4; twenty-three and ninety-nine hundredths (23.99) acres in SV 5 of SV 4; all in Sec. 21, Tp. 2. N. R. 23 E., W. M., in Morrow County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
