## CERTIFICATE OF WATER RIGHT

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 6, at page 291; that the priority of the right thereby confirmed dates from (See individual dates named below)

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 of one cubic foot per second per acre; and shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

FRETA MORIN, Baker, Oregon, Priority of 1865 for 79 acres and 1906 for 56 acres, from Marble, Mill, Morin Springs in NEANET Section 5, for the irrigation of 40 acres in the Northwest quarter of Northeast quarter; 35 acres in the Northeast quarter of Northeast quarter and 40 acres in the Northeast quarter of Northwest quarter of Section Five, Township Nine South, Range Thirty-nine East of Willamette Meridian, in Baker County, Oregon.

W. B. AND L. M. LANDRETH, Baker, Oregon, Priority of 1863, from Marble and Mill Creeks for the irrigation of 20 acres in the Southwest quarter of Southwest quarter and 20 acres in the Southeast quarter of Southwest quarter of Section Thirty-three, Township Eight South, Range Thirty-nine East of Willamette Meridian, in Baker County, Oregon.

JAMES A. KELLEY, Baker, Oregon, Priority of 1865 for 77.5 acres and 1910 for 26 acres, from Marble, Mill & Kelley Springs in SWANEA Section 5, Spring Creek, Cavin & Crabill Springs, for the irrigation of 30 acres in the Southwest quarter of Northeast quarter; 39.5 acres in the Southeast quarter of Northeast quarter and 34 acres in the Southeast quarter of Northwest quarter of Section Five, Township Nine South, Range Thirty-nine East of Willamette Meridian, in Baker County, Oregon.

CHAS. W. KELLEY, Baker, Oregon, Priority of 1863 for 86 acres from Marble & Mill Creeks and McCord Gulch and Spring, and Priority of 1905 for 10 acres from Salmon Creek for the irrigation of 26 acres in the Northeast quarter of Southwest quarter; 58 acres in the Northeast quarter of Southeast quarter and 32 acres in the Northwest quarter of Southeast quarter of Section Five, Township Nine South, Range Thirty-nine East of Willamette Meridian, in Baker County, Oregon.

HARLOW J. EVANS, HERMAN E. JORDAN AND MARY E. JORDAN, Baker, Oregon, Priority of 1864 for 128.7 acres; 1875 for 8 acres and 1905 for 8 acres, from Marble Creek, Mill Creek and Salmon Creek, for the irrigation of 23.7 acres in the Northeast quarter of Northeast quarter; 40 acres in the Northwest quarter of Northeast quarter; 55 acres in the Southeast quarter of Northeast quarter of Southeast quarter of Willamette Meridian, in Baker County, Oregon.
