CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of resonant Route 4, The Dalles , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two wells

a tributary of irrigation

for the purpose of

under Permit No. U-100 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 19, 1936;

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.09 c.f.s. measured at the point of diversion,

or its equivalent in case of rotation.

The point of diversion is located in the SWINEL (Lot 4), Section 32, Township 2 North, Range 13 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-sixtleth of one cubic foot per second per acre. Or its equivalent for each acre irrigated, and shall be further limited to a diversion of hot to exceed 5 acre feet per acre for each acre irrigated during the irrigation season from March 1st to October 1st,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.4 acres in Lot 4 (SMINE2)
0.5 acres in the Charles W. Shang
D.L.C. No. 41 (SWINE2)
Section 32, Township 2 North, Range 13 East., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

After the expiration of fifty years from the date of this certificate or on the expiration of any federal power license issued in connection with this right, and after not less than two years' notice in writing to the holder hereof, the State of Oregon, or any municip thereof, shall have the right to take over the dams, plants and other structures and all appurtena. In thereof, shall have been constructed for the purpose of devoting to beneficial use the water rights specified herein, upon condition that before taking a ossession the State or municipality shall pay not to exceed the fair value of the property so taken, plus such reasonable damages, if any, to valuable, serviceable and dependable property of the holder of this certificate, not taken over, as may be caused by the severance therefrom of the property taken in accordance with the provisions of section 47-508, Oregon Code 1930.
