## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

MALIN IRRIGATION DISTRICT

of Malin ,State of Oregon ,has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mill Creek, sometimes known as Bryant Mountain Gulch & Reservoir to be constructed a tributary of Tule Lake under Permit # R-711 for the purpose of Supplemental Irrigation under Permit No. 12824 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 3. 1937:

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.43 cubic feet per second.

The point of diversion is located in the NELSE of Section 13, Township 41 South, Range 12 East, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the emount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,
