CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, That Henry Boos Johnson of Freewater State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of A well in Crystal Spring watershed, tributary of East Prong of little Walla Walla River (Sometimes call Home Brook), a tributary of a spring creek for the purpose of Irrigation under Permit No. U-88 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 15, 1935; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second, or its equivalent in case of rotation, measured at the point of diversion from the well. The point of diversion is located in the SE $\frac{1}{4}$  NW $\frac{1}{4}$  SE $\frac{1}{4}$  of Section 23, Township 6 North, Range 35 East, W.M.

The amount of water used for irrigation, together within the amount secured under any other right existing for the same lands, shall be limited to one-thirtieth of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

15 acres in the E $\frac{1}{2}$  NW $\frac{1}{4}$  SE $\frac{1}{4}$

Section 23

Township 6 North, Range 35 E, W.M.

The Right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
