CERTIFICATE OF WATER RIGHT

This is to Certify, That MRS. KIZZIE HICKS DAVIS

of Milton

, State of Oregon

has a right to the use of

the waters of Walla Walla River

for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 12, at page 9; that the priority of the right thereby confirmed dates from 1872;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one and one-half miner's inches per acre measured at the point of diversion.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

1.8 acres in SE4SW4. Section 1

T. 5 N., R. 35 E. W. M., being within the following described tract: Commencing at a point on the north line of Martin Street in Ireland's Addition to Milton, Umatilla County, Oregon, 30 ft. in an easterly direction from where said north line of Martin St. intersects the north-and south line running through the center of the NWANW4 of Sec. 12, T. 5 N., R. 35 E. W. M.; running thence north along the east line of Parallel St. 190 ft. to a point of beginning; running thence easterly parallel with the north line of Martin St. and with said north line if the same be extended easterly 420 ft.; thence north 141 ft. to the center of the channel of the Walla Walla River; thence down the center of said channel in a northerly and westerly direction to a point 30 ft. east of the line running north and south through the center of the SW4 of Sec. 1, in said township and range; thence south parallel with said center line to the place of beginning, containing 3-1/3 acres, LESS the following:

Beginning at a point on Parallel St. 380 ft. northerly from the north line of Martin St., in Milton, Umatilla County, Oregon; running thence easterly and parallel with Martin St. if the same were extended easterly, to the center of the channel of the Walla Walla River; thence down the center of the channel of said river to Parallel St.; thence up said street southerly to the place of beginning, containing 1-1/3 acres, more or less.

AND said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
