CERTIFICATE OF WATER RIGHT

This is to Certify, That

JAMES DODD

of Freewater

, State of Oregon

has a right to the use of

the waters of Little Walla Walla River

for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umrtilla County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 12, at page 9; that the priority of the right thereby confirmed dates from 1898 for 1.17 acres, 1903 for 2.31 acres, and 1905 for 1.80 acres;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one and one-half miner's inches per acre measured at the point of diversion.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

5.28 acres in NE₄SW₄ Section 1

T. 5 N., R. 35 E. W. M., being within the following described tract: Beginning at a point 855 ft. south and 30 ft. east of the northwest corner of the NE4SW4, Sec. 1, T. 5 N., P. 35 E. W. M., running thence south 417 ft.; thence east at right angles 729.75 ft.; thence north at right angles 222.5 ft.; thence west at right angles 228.5 ft.; thence north at right angles 188.5 ft.; thence west at right angles 501.75 ft. to the place of beginning, containing 6 acres, EXCEPTING the following described tracts:

Beginning at a point 855 ft. south and 531.75 ft. east of the northwest corner of the NELSWI of Sec. 1, T. 5 N., R. 35 E. W. M., running thence south 188.5 ft.; thence west 115.5 ft.; thence north 188.5 ft.; thence east 115.5 ft. to the place of beginning.

ALSO EXCEPTING the following: Commencing at a point 1212 ft. south and 30 ft. east of the northwest corner of the NE $\frac{1}{2}$ SW $\frac{1}{4}$, Sec. 1, T. 5 N., R. 35 E. W. M., running thence south 60 ft.; thence east at right angles 150 ft.; thence north at right angles 60 ft.; thence west at right angles 150 ft. to the place of beginning. ALSO: Commencing at a point 1212 ft. south and 30 ft. east of the northwest corner of the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Sec. 1, T. 5 N., R. 35 E. W. M., running thence east 150 ft.; thence at right angles north 30 ft.; thence at right angles west 150 ft.; thence south 30 ft. to the place of beginning.

AND said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
