CERTIFICATE OF WATER RIGHT.
(For Rights which have been confirmed by the Courts)

THIS IS TO CERTIFY, That ARTHUR TEMPLETON of Sisters, State of Oregon has a right to the use of the waters of Squaw Creek, a tributary of Deschutes River for the purpose of irrigation of 42 acres of land and domestic use and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for CROOK County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of Oregon, in Volume 1, at Page 120; that the priority of the right hereby confirmed dates from December 6, 1903; that the amount of water to which such right is entitled and hereby confirmed for the purpose aforesaid, is limited to an amount actually beneficially used for said purpose, and shall not exceed 0.84 cubic foot per second.

A description of the lands irrigated under such rights, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: This certificate is intended to correct an error in description of land in decree, and certificate issued to Cloverdale Irrigation Company, recorded in State Record of Water Right Certificates, Vol.1, Page 268, and in Crook County Book of Water Right certificates Vol. 1, Page 77.

The description set forth in such certificate which is hereby declared to be erroneous is as follows: 112 acres in Northwest quarter of Southwest quarter; 302 acres in Southwest quarter of Southwest quarter of Section Thirty-one (31), Township Fourteen (14) South, Range Ten (10) East of Willamette Meridian.

In accordance with the order of the State Water Board recorded on Page 228, Record of Proceedings of State Water Board, the description of the land to which such water right is appurtenant is hereby changed to read as follows: Olla acres in Northwest quarter of Southwest quarter; Sola acres in Southwest quarter of Southwest quarter of Southwest quarter of Section Thirty-one (31), Township Fourteen (14) South, Range Eleven (11) East of Willamette Meridian,
