CERTIFICATE OF WATER RIGHT.  
(For Rights which have been confirmed by the Courts)

THIS IS TO CERTIFY, That ADDIE S. KIMBLE AND M. A. BLACK of Meadows State of Oregon has a right to the use of the waters of Johnson, Miller and Brush Creeks, tributaries of Crooked River for the purpose of Irrigation and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for CROOK County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of Oregon in Volume 1, at page 467; that the priority of the right hereby confirmed dates from 1883 for the irrigation of 398 acres from Johnson Creek and 1891 for the irrigation of 245 acres from Brush Creek; that the amount of water to which such right is entitled and hereby confirmed for the purpose aforesaid, is limited to an amount actually beneficially used for said purpose, and shall not exceed one-eightieth of one cubic foot per second for each acre irrigated, or its equivalent in case of rotation.

A description of the lands irrigated under such rights, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to a beneficial use is as follows:

Johnson Creek -- 4 acres in Southeast quarter of Northeast quarter; 40 acres in Northeast quarter of Southeast quarter of Section Thirteen (13), Township Fourteen (14) South, Range Twenty (20); 14 acres in Northeast quarter of Northeast quarter; 5 acres in Northwest quarter of Northeast quarter; 30 acres in Southwest quarter of Northeast quarter; 40 acres in Southeast quarter of Northeast quarter; 34 acres in Southeast quarter of Northwest quarter; 12 acres in Southwest quarter of Northwest quarter; 40 acres in Northeast quarter of Southwest quarter; 40 acres in Northwest quarter Southwest quarter; 40 acres in Northwest quarter Southeast quarter of Section Eighteen (18), Township Fourteen (14) South, Range Twenty-one (21); 3 acres in Southeast quarter Northeast quarter; 16 acres in Southwest quarter Northeast quarter; 40 acres in Southeast quarter Northwest quarter; 40 acres in Southwest quarter Northwest quarter of Section Seventeen (17), Township Fourteen (14) South, Range Twenty-one (21), all East of Willamette Meridian.

Brush Creek -- 14 acres in Northwest quarter of Southwest quarter; 6 acres in Southwest quarter of Southwest quarter of Section Sixteen (16); 26 acres in Southwest quarter of Southwest quarter; 16 acres in Southwest quarter of Northeast quarter; 3 acres in Southeast quarter Northeast quarter; 7 acres in Northwest quarter Southeast quarter; 15 acres in Northeast quarter Southeast quarter; 32 acres in Northwest quarter Southwest quarter; 18 acres in Northeast quarter Southwest quarter of Section Seventeen (17); 28 acres in Northeast quarter Southeast quarter; 40 acres in Southeast quarter Southwest quarter; 30 acres in Southwest quarter Southeast quarter of Section Eighteen (18), Township Fourteen (14) South, Range Twenty-one (21) East of Willamette Meridian.

The right to the use of the waters aforesaid hereby confirmed is restricted to the lands or place of use herein described.
