CERTIFICATE OF WATER RIGHT

This Is to Certify, That s. A. FULTON

, has a right to the use of

the waters of Little Spring Creek and Big Spring Branch for Tract #1; Big Spring Branch for Tract #2, and Little Spring Branch for Tract #3; for the purpose of Irrigation for Tracts Nos. 1 and 3, and Power for Tract No. 2;

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 12, at page 9; that the priority of the right thereby confirmed dates from 1882;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one and one-half miner's inches per acre measured at the point of diversion for Tracts Nos. 1 and 3, and one cubic foot per second for power development on Tract No. 2.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

W. M., thence south parallel with the east line of said NE, 754.30 ft.; thence at right angles east 557.5 ft.; thence at right angles north 754.30 ft.; thence at right angles west 557.5 ft.

AND said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
