CERTIFICATE OF WATER RIGHT

has a right to the use of

the waters of Walla Walla River and spring which flows across land,

for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 12, at page 9; that the priority of the right thereby confirmed dates from 1885;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one and one-half miner's inches per acre measured at the point of diversion.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

> 10.4 acres in SE4SE4 Section 22, 2.2 acres in NE2NE4 Section 27,

T. 5 N., R. 36 E., W.M., being within the following described tract: Commencing at a point on the Sec. line between Secs. 22 and 23 where the County road as laid out up the valley of the South Fork of the Walla Walla River intersects with said Sec. line; running thence south along the east Sec. line of Secs. 22 and 27, 1550 ft. more or less to the base of the bluff on the south side of the Walla Walla River; thence in a northwesterly direction along the base of the bluff on the south side of the Walla Walla River 550 ft. more or less to the east boundary line of a parcel of land owned at this date by Herman Ruhberg; thence north 1550 ft. more or less to the south line of the County road; thence southeasterly along the south boundary line of the said County road 500 ft. more or less to the point of beginning; all being in Secs. 22 and 27, TP. 5 N., R. 36 E. N. M.. EXCEPTING and reserving therefrom the following described tract of land: Commencing at a point 332 ft. west of the northeast corner of the SEt of Sec. 22, T. 5 N., R. 36 E., W.M., thence west 108 ft.; thence south 1163 ft.; thence northeasterly 1168 ft. to the point of beginning, containing 1.44 acres, more or less.

NOTE: 2 acres of the above irrigated from spring.

AND said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
