## CERTIFICATE OF WATER RIGHT

This is to Certify, That **CLYDE H. HARRIS**

of **Milton**, State of Oregon, has a right to the use of  
the waters of **Walla Walla River**  
for the purpose of **Irrigation**

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for  
**Umatilla** County, and the said decree entered of record at Salem, in the Order  
Record of the STATE ENGINEER, in Volume 12, at page 9; that the priority  
of the right thereby confirmed dates from 1890;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an  
amount actually beneficially used for said purposes, and shall not exceed one and one-half  
miner's inches per acre measured at the point of diversion.

A description of the lands irrigated under such right, and to which the water is appurtenant  
(or, if for other purposes, the place where such water is put to beneficial use), is as follows:

2 acres in NE $\frac{1}{4}$ NW $\frac{1}{4}$   
Section 12,

T. 5 N., R. 35 E. W. M., being within the follow-  
ing described tract: Commencing at a point on the north line of Martin St. in  
Ireland's Addition to Milton, Umatilla County, Oregon, 120 ft. in an easterly  
direction from where said north line of Martin St. intersects the north and south  
line running through the center of the NW $\frac{1}{4}$  of Sec. 12, T. 5 N., R. 35 E. W. M.;  
running thence easterly along the extended north line of Martin St. at right  
angles to Main St. a distance of 330 ft.; thence north 190 ft.; thence westerly  
parallel with the north line of said Martin St. 330 ft.; thence south 190 ft. to  
the place of beginning. EXCEPTING and reserving therefrom a certain right of way  
as described in a deed from Emma Shangle and husband to James M. Hicks, dated  
Oct. 22, 1908 and recorded Oct. 26, 1908 in the public records of Umatilla County,  
Oregon at page 464 of Book 57 Deeds, and further ... EXCEPTING from this deed the  
following described parcel of land heretofore deeded to Claude H. Harris, to-wit:  
Commencing at a point on the north line of Martin St. in Ireland's Addition to  
Milton, Umatilla County, Oregon, at a point 120 ft. in an easterly direction from  
where said north line of Martin St. intersects the north and south line running  
through the center of the NW $\frac{1}{4}$  of Sec. 12, in T. 5 N., R. 35 E. W. M.; thence  
easterly along the north line of Martin St. 113 ft.; thence northwesterly 175 ft.  
more or less to a point on a line drawn parallel with said Martin St. 136 ft.  
easterly from the east line of Parallel St.; thence southwesterly to a point on  
said Parallel line drawn with Martin St. 190 ft. north of the place of beginning;  
thence south 190 ft. to the place of beginning.

AND said right shall be subject to all other conditions and limitations  
contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place  
of use herein described.
