CERTIFICATE OF WATER RIGHT

This is to Certify, That M. HAUN

of R. #1, Freewater , State of Oregon,

has a right to the use of

the waters of Home Brook, a spring creek .

for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 12, at page 9; that the priority of the right thereby confirmed dates from 1887:

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one and one-half miner's inches per acre measured at the point of diversion.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

17.3 acres in NW SE Section 23,

T. 6 N., R. 35 E. W. M., being within the following described tract: The NW4SE of Sec. 23, T. 6 N., R. 35 E. W. M., EXCEPTING the following: A strip of land 15 ft. in width being 15 ft. on the west side of and parallel with the center line of the main tract of the Walla Walla Walley Traction Co. 's line of railway as the same is constructed and on the east line of said NW1SE, of said Sec. 23; ALSO: Beginning at a point on the east side of the right of way of the Walla Walla Talley Traction Company where the Ferndale wagon road running east and west through the center of the SW1 of said Sec. 23 intersects said right of way, and running thence north along the west side of said right of way 400 ft, more or less to a small spring branch which crosses the right of way of said Walla Walla Valley Traction Co.; thence westerly about 50 ft. along the south side of said spring branch to where the waters thereof join the waters of another spring branch or small lake flowing from the south northerly; thence southerly following meenderings of the east side of the last mentioned stream or small lake to the north side of the aforesaid Ferndale wagon road; thence east along the north side of said wagon road to the point of beginning, containing about 0.5 acre. ALSO EXCEPTING THE FOLLOWING: Beginning at the SW cor. of the NW1SE1 of said Sec.23 in said township and range; running thence east along the line running east and west through the center of the SW4 of said Sec. 23, 26 rods and 11 ft.; thence north at right angles 15 rods; thence west at right angles 26 rods and 11 ft. to the center right angles 1) roas; thence west at right angles 20 roas and 11 ft. to the center section line; thence south along said line 15 rods to the place of beginning, containing 2.5 acres. ALSO EXCEPTING the following: Beginning at a point 15 rods north of the SW cor. of NW4SE4 Sec. 23 in said Tp. and Range, running thence east and parallel with the line running east and west through the center of the SW4 of said Sec. 23, 26 rods and 11 ft.; thence north at right angles 3 rods; thence west 26 rods 11 ft.; thence south 3 rods to the place of beginning. AND said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation numbers is restricted to the loads or place AND said right shall be

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
