## CERTIFICATE OF WATER RIGHT

This Is to Certify, That ESTATE OF PETER C. HENDERSON

of Milton

, State of Oregon

, has a right to the use of

the waters of Walla Walla River

for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 12, at page 3; that the priority of the right thereby confirmed dates from 1868:

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one and one-half miner's inches per acre measured at the point of diversion.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

## 2.7 acres in SMANE

T. 5 N., R. 35 E. W. M., being within the following described tracts: Block 3 in Riverside Addition to Milton, Umatilla County, Oregon, according to the duly recorded plat thereof, and including the additions made thereto by reason of the vacation of certain streets adjacent thereto;

ALSO: Commencing at a point 660 ft. east and 505.5 ft. more or less south of the northwest corner of the SW<sub>2</sub>NE<sub>2</sub> of Sec. 12, Tp. 5 N., R. 35 E. W. M., being a point on the west line of the lands at one time granted by Ira W. Phillips and wife to J. M. Morris as recorded in Book 62 of Deeds at page 325, Records of Umatilla County, Oregon, 181.5 ft. south of the line of the County road; running thence south 188.5 ft.; thence east at right angles 140 ft.; thence north at right angles 188.5 ft.; thence west at right angles 140 ft.; more or less, including vacated streets abutting thereon:

cluding vacated streets abutting thereon;

ALSO: Commencing at a point 20 ft. west of the northwest corner of Block 2, in Riverside Addition to Milton, in Umatilla County, Oregon, as shown by the duly recorded plat thereof; running thence east 230 ft. more or less to the angle in the boundary line of Block 1, in said addition; thence running northerly along the line of said Block 1, 245 ft. to the northwest corner thereof; thence west 220 ft.; thence southwesterly on a direct line to a point 194 ft. north of the point of beginning; thence south 194 ft. to the point of beginning.

AND said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
