CERTIFICATE OF WATER RIGHT

(For rights perfected under original, enlargement or secondary permits)

This is to Certify, That GEORGE IRWIN
of Talent , State of Oregon , has made proof
to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the
waters of Wagner Creek , u tributury of Best Creek
, for the purpose of the irrigation of 24.05 acres of land
under Permit No.1668 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered
of record in the Record of Proceedings of said Board, at Salem, in Volume 1
at page 233 , on the 15th day of November, 1916 ; that the priority of
the right hereby confirmed dates from June 5, 1913 ; that the amount of
water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not
exceed 0.30 cubic feet per second, or its equivalent in case of rotation. The use funder shall conform to any reasonable rotation system ordered by the proper State Office and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 15.25 scres in the Southeast quarter of Southeast quarter of Section Twenty-three (23); 3.50 acres in the Southwest quarter of Southwest quarter of Section Twenty-four (24); 0.50 acres in the Northwest quarter of Northwest quarter of Section Twenty-five (25) and 4.8 acres in the Northeast quarter of Northeast quarter of Section Twenty-six, (26), Township Thirty-eight (38) South, Range One (1) West of Willamette Meridian, in Mackson County, Oregon.
