## CERTIFICATE OF WATER RIGHT

This Is to Certify, That . c. l. g. HOPPER

of R. #1, Milton

, State of Oregon

, has a right to the use of

the waters of North Fork Walla Walla River

for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 12, ut page 9; that the priority of the right thereby confirmed dates from 1880;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one and one-half miner's inches per acre measured at the point of diversion.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

## 4 acres in NE4SE4 Section 24

T. 5 N., R. 36 E. W. M. being within the following described tract: Beginning at a wagon skein set in the southern boundary of said County road S. 20 E. and 728.2 ft. distant from the stone marked with a cross at the quarter-Sec. corner between Section 24, T. 5 N., R. 36 E. W. M., and Sec. 19, T. 5 N., R. 37 E. W. M., and on a line between the above mentioned stone and the stone at the southeast corner of the above mentioned Sec. 24, T. 5 N., R. 36 E. W. M., thence S. 20 E. a d'stance of 686.1 ft. to a wagon skein continuing S. 20 E. a further distance of 9.7 ft. to the North bank of the North Fork of Walla Walla River; thence along the northern bank of said stream by the following described courses and distances: N.600 31. W. a distance of 78.2 ft. to a stone 172" x 102" x 82" marked with a cross; thence N. 400 35' W. a distance of 176.6 ft. to a stone 16" x 11" x 5" marked with a cross; thence N.85° 20° W. a distance of 197.4 ft. to a stone 14" x 10" x 6" marked with a cross; thence N. 24° 22° W. a distance of 89.4 ft. to a stone 15" x 9" x 6" marked with a cross; thence N. 16° 55° E. a distance of 261.5 ft. to a stone 21" x 8" x 8" marked with a cross; thence leaving the river bank N. 10° 50° E. a distance of 300 ft. to 1/2 buggy axle set for a monument on the south side of the present county road; thence S. 60° 09° E. a distance of 203.9 ft. to 1/2 buggy axle set on the south boundary of the present County road; thence S. 77° 20' E. a distance of 85.0 ft. more or less to the point of beginning, containing 5.0 acres, more or less.

AND said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use  $herein\ described.$
