## CERTIFICATE OF WATER RIGHT

the waters of South Fork of Walla Walla River

for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 12, at page 9; that the priority of the right thereby confirmed dates from 1888;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one and one-half miner's inches per acre measured at the point of diversion.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

4.0 acres in NE+SW+ 3.0 acres in NW+SW+ Section 10,

T. 4 N., R. 37 E. W. M., being within the following described tracts: Beginning at the northeast corner of the plot of ground sold by Lee W. Roberts to the Pacific Power & Light Co., from thence northerly at right angles to the northerly line of said plot of land sold by Lee W. Roberts to the Pacific Power & Light Co., 16 ft.; thence easterly from the last mentioned line at right angles, 81 ft., said point being southeasterly corner of plot herein conveyed; thence from said southeast corner westerly along a line parallel to and 16 ft. northerly at right angles from northerly line of P. P. & L. Co. plot herein mentioned, said point being southwesterly corner of plot herein conveyed; thence from last mentioned corner on direct line toward aforesaid southeast corner of plot herein conveyed 27 ft.; thence northerly at right angles to last mentioned line 309 ft., said point being northwesterly corner of plot herein conveyed; then starting from southeast corner of plot herein conveyed northerly at right angles from southerly line of same 124 ft.; thence easterly at right angles to last mentioned line 64 ft., said point being northeasterly corner of plot herein conveyed; all connecting lines between corners of plot herein conveyed are straight excepting northerly line which follows southerly line of wagon road. Above plot of ground containing 3 acres, more or less.

ALSO the following: Commencing at the southeast corner of land now owned by second parties (James Kirk and Annie S. Kirk) in Sec. 10, T. 4 N., R. 37 E. W.M., and running thence in a southerly direction 75 ft. to a cottonwood tree, which cottonwood tree is 144 ft. from the easterly end of the rip-rap built by the Pacific Power & Light Co.; thence easterly 328 ft. to a pine tree; said pine tree being 239 ft. from the easterly end of said rip-rap; thence easterly 228 ft. to a large cottonwood tree, which tree is 467 ft. from the easterly end of said rip-rap; thence northeasterly 66 ft. to an apple tree which apple tree is 457 ft. from the easterly end of said rip-rap; thence southwesterly along the north edge ditch and the southerly edge of road (part of the old and some new road) 643 ft. to the northeast corner of this tract hereby conveyed; thence
