CERTIFICATE OF WATER RIGHT

This Is to Certify, That ALBERT D., and CORA E. GARBNER

of Freewater, State of Oregon, has a right to the use of
the waters of Walla Walla River
for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Umatilla County, and the said decree entered of record at Salem, in the Order
Record of the STATE ENGINEER, in Volume 12, at page 9; that the priority
of the right thereby confirmed dates from 1880;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed one and one-half
miner's inches per acre measured at the point of diversion.

A description of the lands irrigated under such right, and to which the water is appurtenant (or,
if for other purposes, the place where such water is put to beneficial use), is as follows:

2.0 acres in SW $\frac{1}{4}$ SW $\frac{1}{4}$

Section 1

T. 5 N., R. 35 E. W. M., being within the follow-
ing described tracts: Commencing at a point on the west line of Main St. in the
Town of Milton, Umatilla County, Oregon, 16 rods more or less due west and 13 rods
due north of the southeast corner of the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Sec. 1, T. 5 N., R. 35 E. W. M.,
running thence west 100 ft.; thence northeasterly at right angles to Main St. to a
point on the west line of Main St. 30 ft. in a northwesterly direction from the
point of beginning; thence southeasterly 30 ft. to the place of beginning.
ALSO: Commencing at a point on the west line of Main St. in Milton, Oregon; as
described in the Wilson survey of March 25th, 1896, 177.11 ft. more or less west
of the southeast corner of the SW $\frac{1}{4}$ SW $\frac{1}{4}$ Sec. 1, T. 5 N., R. 35 E. W. M., running
thence west 36.4 ft. to the east line of the land owned by J. E. Burgess on the
10th day of September, 1902; thence north along said line 78 ft. more or less to
its intersection with the west line of Main St. as surveyed March 25, 1896 by
L. A. Wilson, City Surveyor; thence southeasterly along the west side of said
Main St. 100 ft. more or less to the place of beginning, all in Milton, Umatilla
County, State of Oregon.

ALSO: Commencing at a point 13 rods west of the southeast corner of the SW $\frac{1}{4}$ SW $\frac{1}{4}$
of Sec. 1, T. 5 N., R. 35 E. W. M., running thence west 20 rods 15.5 ft.; thence
north 13 rods; thence east 20 rods 15.5 ft.; thence south 13 rods to the place of
beginning.

AND said right shall be subject to all other conditions and limitations
contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use
herein described.
