CERTIFICATE OF WATER RIGHT

This Is to Certify, That TASSEY STEWARD

of Milton, State of Oregon, has a right to the use of
the waters of Walla Walla River
for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Umatilla County, and the said decree entered of record at Salem, in the Order
Record of the STATE ENGINEER, in Volume 12, at page 9; that the priority
of the right thereby confirmed dates from 1880;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed one and one-half
miner's inches per acre measured at the point of diversion.

A description of the lands irrigated under such right, and to which the water is appurtenant (or,
if for other purposes, the place where such water is put to beneficial use), is as follows:

4.2 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$
Section 2,

T. 5 N., R. 35 E. W. M., being within the follow-
ing described tracts: In Umatilla County, Oregon; Commencing at a point 26-28/37
rods north and 18 rods west of the southeast corner of Sec. 2, T. 5 N., R. 35 E.
W. M., running thence west 16 rods; thence south 10 rods; thence east 16 rods;
thence north 10 rods to the place of beginning, containing 1 acre, more or less.

ALSO: Beginning at a point 43-9/37 rods south 297 ft. west of the northeast
corner of the S $\frac{1}{2}$ of the SE $\frac{1}{4}$ of Sec. 2, T. 5 N., R. 35 E. W. M., running thence
west 148.6 ft. more or less to the extended east line of the street heretofore
deeded by J. E. Hoon to Milton City; thence south 11 ft.; thence east 148.6 ft.;
thence north 11 ft. to the place of beginning.

ALSO: Commencing at a point 43-9/37 rods south of the northeast corner of
the S $\frac{1}{2}$ of the SE $\frac{1}{4}$ of Sec. 2, in T. 5 N., R. 35 E. W. M., running thence west 18
rods; thence south 17-7/9 rods; thence east 18 rods; thence north 17-7/9 rods
to the place of beginning, containing 2 acres.

ALSO: Commencing at a point 36-28/37 rods north and 18 rods west of the
southeast corner of Sec. 2, T. 5 N., R. 35 E. W. M., running thence west 16 rods;
thence south 10 rods; thence east 16 rods; thence north 10 rods to the place of
beginning, containing 1 acre.

AND said right shall be subject to all other conditions and limitations
contained in said decree.
The right to the use of the water for irrigation purposes is restricted to the lands or place of use
herein described.
