CERTIFICATE OF WATER RIGHT

This is to Certify, That LYMAN B., and ORPHA B. VAUGHAN

of Milton, State of Oregon has a right to the use of
the waters of Walla Walla River
for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 12, at page 9; that the priority of the right thereby confirmed dates from 1870;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one and one-half miner's inches per acre measured at the point of diversion.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

3 acres in SE¹/₄ NW¹/₄
Section 12

T. 5 N., R. 35 E. W. M., being within the following described tracts: In Milton City, Umatilla County, Oregon: Commencing at the northwest corner of Lot 5 in Block 3 of Gross Addition to Milton, running easterly along the northerly line of Lot 5, 29.5 ft. to the point of beginning; running thence northwesterly in a direct line 143.5 ft. to a point on the southeasterly line of Black's Addition to Milton, which line is N. 43° E. 133 ft. from the easterly line of Vine St.; thence N. 43° E. 38 ft.; thence S. 65° 15' E. to the intersection of the produced northwesterly line of Lots 3, 4, 5 and 6, in said Block 3, if the same were extended northeasterly 111.75 ft. from the southeasterly corner of Lot 2 in said Block 3; thence northeasterly along said produced line 8.25 ft. more or less; thence N. 87° E. 64 ft. more or less; thence southeasterly 59 ft. more or less to a point on the north line of Berry St. in said Gross Addition to Milton 60 ft. northeasterly from the southeasterly corner of Lot 6 in said Block 3; thence southwesterly along the northerly line of said Berry St. 131.5 ft. to a point on the said north line of Berry St. 28.5 ft. northeasterly from the southwest corner of Lot 5 in said Block 3; thence northwesterly in a direct line to the point on the north line of Lot 5 in said Block 3, 29.5 ft. from the northwest corner of said Lot 5, the place of beginning.

ALSO: Lot 1 in Block 4, and Lots 1, 2, 3 and 4, in Block 3, in Gross's Addition to Milton, Umatilla County, Oregon, according to the duly recorded plat thereof.

ALSO: Commencing at the northwesterly corner of Lot 1, Block 5, Gross's Addition to Milton, said County and State, running thence northeasterly along the northwesterly line of Lot 1, 100 ft.; thence southeasterly along the north-easterly lines of Lots 1 and 2 and 4 in said Block, 200 ft.; thence northeasterly along the southeasterly line of Lot 5 in said Block, 28.5 ft.; thence northwesterly and parallel with the southwesterly line of said Block 3, 242 ft.; thence S. 43° W. 129.5 ft. to the northeasterly line of Vine St.; thence south-easterly along the northeasterly line of Vine St. 42 ft. to the corner of Lot 1, Block 3, in said Addition to the point of beginning.

ALSO: Commencing at a point on the east line of College Ave., in Columbia Heights Addition to Milton, 50 ft. northeasterly from the southeast corner of Lot 5, Block 3, Columbia Heights Addition to Milton, where the south line of said lot if extended would intersect the said east line of College Ave.; running thence northeasterly 40 ft. to the southwest corner of Lot 1, Block 4, Gross's

Addition to Milton; thence northwesterly along the westerly line of said Lot 1, 50 ft. to the northwest corner of said Lot 1; thence northeasterly along the northwesterly line of said Lot 1, 160 ft. to the northwest corner of Lot 1, Block 3, Gross's Addition to Milton; thence northwesterly 42 ft. more or less in a direct line with the southwesterly line of said Block 3, Gross's Addition to Milton, to the southwesterly line of Lot 7, Block 3, Black's Addition to Milton; thence southwesterly along the line of Block 3, Black's Addition, to the southerly corner of said Black's Addition to Milton; thence northwesterly along the southwest line of said Block 3, Black's Addition, to the southwest corner of Lot 9, Block 3, in said Black's Addition; thence south to the intersection of the easterly line of College Ave.; thence southeasterly 500 ft. more or less to the easterly line of College Ave., to the point of beginning.

AND said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
