11 |1 **1**2 and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 12, , at page 9; that the priority of the right thereby confirmed dates from 1868;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one and one-half miner's inches per acre measured at the point of diversion.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

1.75 acres in SEINWI Section 12

T. 5 N., R. 35 E. W. M., being within the following described tract: From the southeast corner of Block 1, in Ireland's Addition to Milton, Umatille County, Oregon, run easterly along the extended south line of said Block 535.4 ft. and southerly parallel with center line of Grover St.10 ft. to a place of beginning: Running thence northerly parallel with the center line of Grover St. 210.2 ft.; thence westerly at right angles 208 ft.; thence southerly parallel with the center line of Grover St.210 ft. more or less to a point on a line drawn parallel with and 10 ft. at right angles southerly from the extended south line of said Block 1; thence easterly along said parallel line 208 ft. more or less to the place of beginning; ALSO:

Beginning at the northeast corner of Block 1 in Ireland's Addition to Milton, Umatilla County, Oregon, running thence easterly at right angles to Grover St., 160 ft.; thence northerly at right angles and parallel with Grover St. 10 ft. to a place of beginning; thence running southerly parallel with Grover St. 110 ft.; thence easterly at right angles 325 ft.; thence northerly parallel with Grover St. 35 ft. more or less to a point 25 ft. distant from the land of E. D. Walker; thence northwesterly on a line parallel with and 25 ft. distant from the land of E. D. Walker aforesaid 160 ft. more or less to a point opposite the place of beginning and at right angles to Grover St.; thence in a straight line to the place of beginning.

AND said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
