for the purposesof irrigation and domestic use, (irrigation during the irrigation season)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Morrow County, and the said decree entered of record at Salem, in the Order Record of the Board of Control of the State of Oregon, in Volume 1, at page 73; that the priority of the right hereby confirmed dates from 1884 for domestic use, from 1892 for the irrigation of one hundred and thirty-five (135) acres, and from 1906 for the irrigation of one hundred and four (104) acres,

that the amount of water to which such right is entitled and hereby confirmed for the purpose saforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.25 cubic feet per second as of date 1892 and 1.74 cubic feet per second as of date 1906.
