## CERTIFICATE OF WATER RIGHT

This is to Certify, That G. W. HALES

of O'Brien, State of Oregon has a right to the use of  
 the waters of East Fork Illinois River  
 for the purpose of mining

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Josephine County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 13, at page 70; that the priority of the right thereby confirmed dates from 1895;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 75.0 cubic feet per second.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

NOTE: This certificate confirms a change in place of use of water approved by an order of the State Engineer dated November 25, 1935, wherein the right to the use of water for mining purposes on Mineral Lot No. 38, Section 3, Township 41 South, Range 8 West, W. M., was transferred to the lands hereinabove described.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
