CERTIFICATE OF WATER RIGHT

This Is to Certify, That FANNIE TRIMBLE

of Brookings , State of Oregon , has a right to the use of

the waters of springs in Std NEd, Section 28, Township 38 South, Range 8 West, W. H., for the purpose of irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for

Josephine County, and the said decree entered of record at Salem, in the Order

Record of the STATE ENCINEER, in Volume 13, at page 70; that the priority

of the right thereby confirmed dates from 1908;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one cubic foot per second for each 50 acres of land irrigated during the irrigation season from April 1 to November 1 of each year.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

15 acres in SW NET
8 acres in NET SW
8 acres in NW SET
Section 28,
T. 38 S., R. 8 W., W. M.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
