	of record in the Record of Proceedings of said Board, at Salem, in Volume 1 ,
	at page 236 , on the 8th day of February, 1917 : that the priority of
	the right hereby confirmed dates from August 9, 1915 ; that the amount of
	water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not
hereun	exceed 1.00 cubic feet per second, or its equivalent in case of rotation. The user shall conform to any reasonable rotation system ordered by the proper State Office of description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 40 acres in the Southeast quarter of Northwest quarter and 40 acres in the Northeast quarter of Southwest quarter of Section Twenty (20), To ship One (1) North, Range Ten (10) East of Willamette Meridian, in Hood River County, Oregon.
	The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described. Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
