CERTIFICATE OF WATER RIGHT

This Is to Certify, That

NELSON M. NYE, ELSIE PHIPPS, C. W., C. D., and CLEM CLARK

of Prospect , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Fork of Rogue River and waste water from C. O. P. Co. flume a tributary of Rogue River for the purpose of Irrigation, Supplemental Irrigation, and Stock under Permit No. 6119 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 22, 1923

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.0 cubic feet per second, being 3.39 c.f.s. for irrigation and supplemental irrigation, and 0.61 c.f.s. for stock,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 SW4, Section 29, Township 32 South, Range 3 East, W. M., and NW4 NW4, Section 6, Township 33 South, Range 3 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall also be limited to the water available at the proposed point of diversion and shall not carry with it the right to compel the continuance of the waste water,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
