that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.68 cubic feet per second, being 3.53 c.f.s. for Irrigation and 1.15 c.f.s. for Domestic and Stock,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SE4, Section 9, Township 32 South, Range 3 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighticth of one cubic foot per second per acre, at its equivalent for each acre irrigated,
