CERTIFICATE OF WATER RIGHT

of Route 1, Gold Hill ,State of Oregon ,has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Long Gulch, tributary of Right Fork of Foots Creek, tributary of Foots Creek, a tributary of Rogue River for the purpose of Irrigation, Domestic, and Mining under Permit No. 14501 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 19, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.08 cubic feet per second, being 0.07 c.f.s. for irrigation, 0.01 c.f.s. for domestic, and 1.0 c.f.s. for mining,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NN1 SE1, Section 15, Township 37 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2 to October 31 of each year,
