CERTIFICATE OF WATER RIGHT

THIS IS TO CERTIFY, That R. R. ROGERS of Spokane, State of Washington, has a right to the use of the waters of Silver Creek for the purpose of irrigation, domestic, and stock and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Harney County, and the said decree entered of record at Salem, in the Order Record of the State Engineer, in Volume 12, at page 298; that the priorities of the right thereby confirmed date from 1883, 1886, 1887, 1888, 1892, 1894, 1896, 1899, 1900, and September 2, 1901, for the lands hereinafter described; that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/60th of one cubic foot per second per acre irrigated from March 1 to April 30, and 1/80th of one cubic foot per second from May 1 to August 1; provided, that the total quantity diverted during the months of March, April, May, and June shall not exceed 2.5 acre-feet per acre.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
