## CERTIFICATE OF WATER RIGHT

This Is to Certify, That BEN F. DORRIS

of Springfield, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of A Channel of Willamette River a tributary of \_\_\_\_\_ for the purpose of Irrigation and Stock, under Permit No. 13041 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 14, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.26 cubic feet per second, being 1.25 c.f.s. for irrigation and 0.01 c.f.s. for stock,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 11, Township 18 South, Range 3 West, W. M., being within William Masterson D. L. C. 61.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Stock and 23.4 acres in the NE $\frac{1}{4}$  SW $\frac{1}{4}$   
 Stock and 32.1 acres in the SE $\frac{1}{4}$  SW $\frac{1}{4}$   
 Stock and 0.4 acre in the NW $\frac{1}{4}$  SE $\frac{1}{4}$   
 Stock and 20.2 acres in the SW $\frac{1}{4}$  SE $\frac{1}{4}$   
 Stock and 0.6 acre in the SE $\frac{1}{4}$  SE $\frac{1}{4}$ ,  
 Section 2,  
 Stock and 0.8 acre in the NE $\frac{1}{4}$  NE $\frac{1}{4}$   
 Stock and 4.9 acres in the NW $\frac{1}{4}$  NE $\frac{1}{4}$   
 Stock and 17.3 acres in the NE $\frac{1}{4}$  NW $\frac{1}{4}$   
 Section 11,  
 T. 18 S., R. 3 W., W. M.  
 Being within William Masterson D. L. C. 61.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
