CERTIFICATE OF WATER RIGHT

This Is to Certify, That GEORGE J. WENDEROTH.

of Azalea, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Four Springs and McGinnis Creek, a tributary of Cow Creek for the purpose of Irrigation & Domestic, being 0.04 c.f.s. for irrigation & 0.01 c.f.s. for domestic under Permit No. 13103 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 6, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second, being 0.005 c.f.s. from each of two springs in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 27, for domestic; 0.01 c.f.s. from two springs in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 27, for irrigation; and 0.03 c.f.s. from McGinnis Creek for irrigation,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ from McGinnis Creek; NE $\frac{1}{4}$ SW $\frac{1}{4}$ from Springs Nos. 1 & 2; and NW $\frac{1}{4}$ SE $\frac{1}{4}$ from Springs Nos. 3 & 4, Section 27, Township 31 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-seventieth of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season from April 1st to October 1st of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic in the NE $\frac{1}{4}$ SW $\frac{1}{4}$,
2.5 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$,
Section 27,
T. 31 S., R. 4 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
