**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** **WILLIAM H. BAGLEY**

of **Route 1, Forest Grove**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **An Unnamed Creek, tributary of Gales Creek, and Gales Creek, a tributary of Tualatin River** for the purpose of **Irrigation** under Permit No. **13257** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **August 30, 1938**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.375 cubic foot per second,**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 27, in Marvil W. Watts D. L. C. 48; SE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 27, in George W. Fearnside D. L. C. 49; and NW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 34, in David Allen D. L. C. 47, all in Township 1 North, Range 4 West, W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$  acre feet per acre** for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**0.6 acre in the NE $\frac{1}{4}$  SW $\frac{1}{4}$   
 7.3 acres in the SE $\frac{1}{4}$  SW $\frac{1}{4}$ ,  
 Section 27,  
 T. 1 N., R. 4 W., W. M.,  
 being within Geo. W. Fearnside D. L. C. 49;**

**0.4 acre in the SW $\frac{1}{4}$  SW $\frac{1}{4}$   
 11.4 acres in the SE $\frac{1}{4}$  SW $\frac{1}{4}$   
 4.2 acres in the SW $\frac{1}{4}$  SE $\frac{1}{4}$ ,  
 Section 27,  
 6.1 acres in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ ,  
 Section 34,  
 T. 1 N., R. 4 W., W. M.,  
 being within David Allen D. L. C. 47.**

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
