## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That.

R. E. WILLIAMS and L. H. THACKER

of 1202 Porter Building, Portland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River and A Slough, tributary of Rickreall Creek, a tributary of Willemette River for the purpose of Irrigation under Permit No. 14091 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 8, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.98 cubic feet per second, being 0.99 c.f.s. from each source.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL SWL, Section 25, and NWL NWL, Section 36, Township 7 South, Range 4 West, W. M., being within Joshua Shaw D. L. C. 60; and NEL NEL, Section 36, Township 7 South, Range 4 West, being within William Duran D. L. C. 61.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,
