the right hereby confirmed dates from March 17, 1916 ; that the amount of
water to which such right is entitled and hereby confirmed, for the purposes aforesuid, is limited to an amount actually beneficially used for said purposes, and shall not
exceed 1.00 cubic feet per second.
A description of the lands under such right, and to which the water hereby confirmed is appartenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: Southwest quarter of Southeast quarter of Section Twenty-nine (29), Township Twenty-six (26) South, Hange Twelve (12) West of Willamette Meridian, in Coos County, Oregon.
