## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That MRS. MILDRED THIESSEN

of Hazeldorf Apts., Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Two Unnamed Springs, being 0.05 c.f.s. from each spring,

for the purpose of

irrigation, Stock, and Domestic under Permit No. 13061 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 6, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.045 cubic foot per second, being 0.02 c.f.s. for irrightion and 0.025 c.f.s. for domestic and stock,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NET SET (Spring No. 1) Section 9 and NW1 SET (Spring No. 2) Section 10, Township 8 South, Range 2 West, W. M., being within Abram Olinger D. L. C. 57.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic and Stock in the SEL NET Stock and 0.3 acre in the NET SET Domestic and Stock in the SEL SEL, Section 9, Stock in the SWL NWL Stock and 0.5 acre in the NWL SWL Domestic and Stock in the SWL SWL, Section 10,

T. & S., R. 2 W., W. H., being within Abram Olinger D. L. C. 57; Domestic in Lot 6 (SWL SWL), Section 10,

T. & S., R. 2 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
