CERTIFICATE OF WATER RIGHT

This Is to Certify, That. VIOLET PARKER

of North Powder , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of waste water from Daugherty Field & the waters of North Fowder River a tributary of Powder River for the purpose of

Irrigation and Supplemental Irrigation

under Permit No. 13070 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 14, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.43 cubic foot per second from North Powder River and 0.39 c.f.s. waste water to be supplemented by 0.39 c.f.s. from Morth Powder River when the waste water is not available, provided that the total quantity diverted shall not exceed 0.82 c.f.s.,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SET SWL, Section 14, and NET SET, Section 28, Township 6 South, Range 39 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, for each acre irrigated from March 1, to July 1, and one-eightieth of one cubic foot per second for each acre irrigated from July 1, to October 1, of each year, and shall also be limited to the water available at the proposed point of diversion and shall not carry with it the right to compel the continuance of the waste water.

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The provisions of this certificate are subject to the stipulation of September 25, 1942 between North Powder Milling and Mercantile Company by Chris E. Johnson, Vice President, and Violet Parker and subject especially to the following clause in that stipulation: "Diversion of water from the tail race of the North Powder Milling and Mercantile Company for use on the lands herein described is limited to such times as water is flowing in said tail race by authority of said Company, its agents, licensees, successors or assigns."

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
