CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That C. E. and A. B. DAVIS

of North Powder State of Oregon has a right to the use of the waters of North Powder River, a tributary of Powder River

for the purpose of the irrigation of 812 acres of land and domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 5 at page 252 ; that the priority of the right hereby confirmed dates from the year 1873 for the irrigation of 70 acres; from 1888 for 496 acres; from 1906 for 25 acres.. from 1877 for 69 acres and from 1903 for 152 acres

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of flow of 20.30 sec.ft. from March 1st to July 1st and 10.15 sec. ft. from July 1st to October 1st of each year; the total quantity diverted during each irrigation season not to exceed 2,030 acre feet

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 28 1/2 acres in SW 1/4 of SW 1/4; 19 1/2 acres in SE 1/4 of SW 1/4; 15 1/2 acres in SW 1/4 of SE 1/4; 12 1/2 acres in SE 1/4 of SE 1/4; Section Thirty-six (36); 1 1/2 acres in NE 1/4 of SE 1/4; 38 1/2 acres in SE 1/4 of SE 1/4; Section Thirty-five (35), Township Six (6) South, Range Thirty-eight (38) East of Willamette Meridian; 160 acres in NE 1/4; 80 acres in E 1/2 of NW 1/4; 40 acres in NW 1/4 of NW 1/4; 37 acres in SW 1/4 of NW 1/4; 80 acres in N 1/2 of SE 1/4 Section One (1); 40 acres in NE 1/4 of NE 1/4; 38 acres in SE 1/4 of NE 1/4; Section Two (2), 26 acres in NE 1/4 of NE 1/4; 1 1/2 acres in NW 1/4 of NE 1/4; 36 1/2 acres in SE 1/4 of NE 1/4; Section Eleven (11), 80 acres in N 1/2 of NW 1/4; 39 acres in SW 1/4 of NW 1/4; 38 acres in SE 1/4 of NW 1/4; Section Twelve (12), Township Seven (7) South, Range Thirty-eight (38) East of Willamette Meridian; all in Baker County, Oregon.
