CERTIFICATE OF WATER RIGHT

This Is to Certify, That Pat Foley

of The Dalles, State of Oregon, has a right to the use of

the waters of Thornton springs for tract # 1, storage of 48 acre feet in Big Lake for tract # 2, and storage of 12 acre feet in Little Lake for tract # 3, for the purpose of Irrigation, domestic and stock and fish propagation for tract # 1, and irrigation for tracts Nos. 2 and 3, and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for WASCO County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 10 at page 219; that the priority of the right thereby confirmed dates from 1860 for tract # 1, and 1914 for tracts Nos. 2 and 3,

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3 acre-feet per acre, measured at the point of diversion from the stream, which may be diverted at a rate not to exceed 1/60th of one cubic foot per second per acre during the irrigation season from March 1 to October 1 of each year.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

6 acres in NW $\frac{1}{4}$ NW $\frac{1}{4}$,
2.8 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$,

1.3 acres in NE $\frac{1}{4}$ NE $\frac{1}{4}$,
1.4 acres in SE $\frac{1}{4}$ NE $\frac{1}{4}$,

TRACT # 2

2 acres in NE $\frac{1}{4}$ NE $\frac{1}{4}$,
Section 30,
2 acres in NW $\frac{1}{4}$ NW $\frac{1}{4}$,
Section 29,
2 acres in SW $\frac{1}{4}$ SW $\frac{1}{4}$,
Section 20,
2 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$,
Section 19,
T. 2 N., R. 13 E., W. M.

TRACT # 3

1 acre in NE $\frac{1}{4}$ NE $\frac{1}{4}$,
Section 30,
3 acres in NW $\frac{1}{4}$ NW $\frac{1}{4}$,
Section 29,
T. 2 N., R. 13 E., W. M.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
