# CERTIFICATE OF WATER RIGHT

This Is to Certify, That Harry A. Withers

, has a right to the use of

the waters of East Fork Rattle Snake Creek for Tracts Nos. 1, 3, 4 and 5; Middle Fork Rattlesnake Creek for Tracts Nos. 2 and 6; for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
HARNEY County, and the said decree entered of record at Salem, in the Order
Record of the STATE ENGINEER, in Volume 13, at page 453; that the priority
of the right thereby confirmed dates from 1886 for Tract No. 1; 1885 for Tracts Nos. 2 and 3;
1923 for Tracts Nos. 4 and 6; 1929 for Tract No. 5;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed three acre feet per acre during any year and the head of water shall not exceed one cubic foot per second for each 25 acres of land to be irrigated.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

## TRACT NO. 4

15.2 acres in NWASEA, 1.5 acres in SEANEA, 9.7 acres in SWANEA, Section 30, T. 22 S., R. 322 E., W. M.

#### TRACT NO. 5

18.8 acres in NW4SE4, Section 30, T. 22 S., R. 32½ E., W. M.

## TRACT NO. 6

12.5 acres in Lot 3, Section 30, T. 22 S., R. 32 E., W. M.

And said right shall be subject to all other limitations and conditions contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
