## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That PETER S. RICE

of Mapleton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Park Creek

a tributary of Siuslaw River Irrigation

for the purpose of

under Permit No. 12844 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 1, 1937

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.20 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 11 (SE2 SN1), Section 11, Township 18 South, Range 10 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.2 acres in Lot 11 (SE SK4), 5.2 acres in Lot 10 (SK4 SE4), 0.4 acre in Lot 7 (NK4 SE4), Section 11, T. 18 S., R. 10 W., N. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

A tract of land in Sec. 11 Tp 18 S R 10 W. Will Mer. and more fully described as follows:

Beginning at the North West corner of the S.E. of the S.W. of the said Sec. 11 in said Township and Range, and running thence North on the forty line for a distance of 841 ft; thence S 54° 30° E. 1250 ft. to the westerly boundary of the right of way of the S.P.R.R. Company; thence on the same course across the said right of way and across the right of way of the Willamette Florence Highway for a distance of 300 ft. more or less to the easterly boundary of the said highway; thence S 15° 05° E 1250 ft. to the Siuslaw River; thence southerly with the said river 330 ft. to the South line of said Sec. 11; thence West along the Section line 280 ft. to the East line of land previously deeded to Peter S. Rice; thence N 3° E along the said line 1080 ft. nore or less, to the South-Easterly boundary of said Willamette Florence Highway, thence on the same course 240 ft. to the N E corner of the said Peter S. Rice land; thence West 200 ft. to the West line of said S.P.R.R. right of way; thence West on the North Line of land owned by said Peter S. Lice and H. T. Robinson for a distance of 950 ft. to place of beginning, containing exclusion of the said right of ways 22.9 acres of land, all in Lane County, Oregon.

Beginning at a point on the Section line between Section's fourteen & Eleven, ten chains East of the following described corner to vit: the South West corner of Lot Eleven Section Eleven Twp. Fighteen, South of Range Ten West Willamette Meridian, where a post four inches square marked C. S established by the County Surveyor and accepted by the present owners of the adjoining property as marking the South West corner of said lot number Eleven, and standing exactly on the Section line between Section's Eleven and Fourteen, East twenty chains from the corner of Section's Ten, Eleven, Fourteen & Fifteen of said Twp. and Range, using a variation of Twenty degrees East thence East Seven and one half chains; thence Horth Twenty chains; thence West Twelve and one half chains; thence South Twelve and one half chains to the point of beginning, containing eighteen and three fourth's of an acres, all in said lot Number Eleven, Section Eleven, Twp. Eighteen South of Range Ten Eest Willamette Meridian, County of Lane State of Oregon.

In addition to above described land a tract of land also described by metes and bounds adjoining said described lands on the east. All within Lots Seven, Ten and Eleven of same Section Tap and Range is part of the irrigated land covered by this permit but since the description is quite lengthy is omitted.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
