CERTIFICATE OF WATER RIGHT

This Is to Certify, That OREN McNULTY

of Rt. 2, Woodburn, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Butte Creek a tributary of Pudding River for the purpose of Irrigation under Permit No. 13136 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 1, 1937

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected on John Killins D.L.C. No. 72, Section 11, Township 5 South, Range 1 West, R. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected on John Killins D.L.C. No. 72
20.0 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected on John Killins D.L.C. No. 72
Section 11,
T. 5 S., R. 1 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

That portion of the west half of the John Killin Donation Land Claim #72 in Section Eleven (11) Township Five (5) South, Range One (1) West of the Willamette Meridian, described as follows:

Beginning at an iron bar in the west line of said Section Eleven (11) that is south 4.615 chains from the west quarter corner thereof; thence east 16.10 chains to an iron bar that is the most westerly northwest corner of the 5.99 acre tract conveyed by Jane Dodge, et al, to J. C. Wilson by deed recorded in Book 142, page 490 of the Marion County deed records; thence south 7 degrees 25 minutes west along the west line of said tract 13.54 chains to an iron bar in the center line of the County road, thence along said center line north 53 degrees 19 minutes east 3.66 chains to an iron bar; thence along said center line south 84 degrees 34 minutes east 1.40 chains to the west side of Butte Creek; thence southerly following said Creek to the northeast corner of the three acre tract conveyed by Marion Dodge, et ux, to Edger Dodge, by deed recorded in Book 71, page 107, of said Marion County deed records; thence west along the north line of said tract to the west line of said Claim #72, and which is also the west line of the said Section Eleven (11); thence North along said West line 33 chains to the place of beginning, subject, however, to rights for public roads.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
