This Is to Certify, that Christian K. Hansen

of Springfield , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Creek

a tributary of McKenzie River Irrigation

for the purpose of

under Permit No. 13597 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 19, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.61 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SE as projected on Herod Johnston D.L.C. No. 62,

Section 28, Township 17 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toons—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.3 acres in the SE; SW; as projected on Herod Johnston D.L.C. No. 62
13.8 acres in the NE; SW; as projected on Herod Johnston D.L.C. No. 62
14.0 acres in the HE; SW; as projected on Albert S. Powers D.L.C. No. 49
2.0 acres in the NW; SE; as projected on Albert S. Powers D.L.C. No. 49
9.2 acres in the SE; NW; as projected on Albert S. Powers D.L.C. No. 49
2.4 acres in the SW; NE; as projected on Albert S. Powers D.L.C. No. 49
Section 28,
T. 17 S., R. 2 W., W.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Commencing at the most eastrly South Eeast corner of the Albert S. Powers donation claim, notification number 7579 claim number 49 in township 17 South of Range number 2 West. Thence west on south boundry of said claim 5.68 chains. Thence 28.00 chains parallel with the east boundry of said claim to the north line of the same. Thence 5.68 chains to the north east corner of the same. Thence south along the east line of said claim 28.00 chains to place of beginning, containing 15 and 90/100 acres.

Beginning at the northeast corner of the Herod Johnson and donation land claim No. 62, No. f. 7481, in Section 28 in Township 17 S. R. 2 West of the Fillamette Meridian, and running thence South along the east line of said claim to the center of the county road No. 440, thence Westerly along center of said road to the west line of said claim, thence North along said West line to the northwest corner of said claim, and thence East to the place of beginning, containing 28 ecres, more or less, all in Lane County, State of Oregon.

Commencing at the N W corner of the Herod Johnson Donation Land Claim in Section 28 am 29 in Township 17 S. R. Two West of Willemette Meridian, thence East 15.84 chains, thence North 29 chains, thence West 15.84 chains, thence South 29 chains to the place of beginning containing 45 acres more or less, in Lane County, Oregon.
