CERTIFICATE OF WATER RIGHT

This Is to Certify, That MRS. G. M. WALKER

of Seaside, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Champoeg Creek a tributary of Willamette River for the purpose of Irrigation under Permit No. 13648 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 2, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.49 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected on John B. Goodell D.L.C. 91, Section 11, Township 4 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 13.5 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected on John B. Goodell D.L.C. No. 91
- 21.1 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected on John B. Goodell D.L.C. No. 91
- 2.0 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ as projected on John B. Goodell D.L.C. No. 91
Section 11,
- 2.0 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ as projected on John B. Goodell D.L.C. No. 91
Section 14,
T. 4 S., R. 2 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by appropriator as follows:

Beginning at a red fir tree 48 inches in diameter 15 chains West and 7.90 chains North of the corner to section 11, 12, 13 and 14 and running thence North 33 $\frac{1}{2}$ ^o East 9.94 chains, thence North 36 3/4^o West 14.98 chains, thence South 27 $\frac{1}{2}$ ^o West 14.11 chains; thence South 52^o East 12.55 chains to the place of beginning, containing 15.76 acres and being a part of section 11 in said Township 4 South of Range 2 West of the Willamette Meridian in Marion County, Oregon.

Also, Beginning at a point 10.14 chains North and 6.48 chains East of the South West corner of Donation Land Claim No. 91, of Township 4 South of Range 2 West and running thence East 13.86 chains to the North East corner of a tract of the said Claim No. 91 sold to John Hoefler, thence South 3.70 chains to a North West corner of a tract of the same, sold to Casper Zorn, thence East 32.74 chains to the East boundary of Claim No. 91, thence along said boundary North 27 $\frac{1}{2}$ ^o East 12.86 chains, thence West 52.54 chains and South 7.69 chains to the place of beginning, containing 51 1/3 acres.

Also, Beginning at the North West corner of the Donation Land Claim of Robert Childers and wife, in Township 4 South, Range 2 West of the Willamette Meridian in

Marion County, Oregon, running thence South with the West boundary line of said Claim across the Creek commonly known as Cases Creek to the foot of the bluff of said Creek thence Northerly with the meanders of said Bluff to the intersection of the North boundary line of said Donation Claim; thence West on the said North line to the said North West corner of said Donation Claim to the place of beginning, containing 25 acres, more or less.

Save and except from the above described lands, all Roads and Roadways.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
